Liability and Release + Rental Agreement

For review purposes ONLY. A signable electronic version of this document will be provided by Wave prior to your tour. Each guest should be prepared to review and sign the document at that time.

This waiver of Liability and Release must be read and agreed to by everyone participating in all activities, events or services run by Wave Limo & Tours. Participation in said activities, events or services is prohibited unless this form has been reviewed and signed. This consent is valid throughout the duration of participation of the signor in the specific activity, event or service as stated above.

Wave Limo & Tours' activities, events and services are defined as follows:

- Tours (libations, culinary, adventure/tourism, etc.)
- Other Services:
 - Hourly/Personal Chauffeur
 - Bachelor/Bachelorette Parties
 - Special Events (Birthday, Prom, Graduation, Anniversaries)
 - Weddings
 - Golf Outings
 - Airport Shuttles
 - Corporate & Conferences
 - Helicopter Tours & Charters
 - Concerts & Major Sporting Events
 - Students & Sports Teams

Cancellation Policy:

- There is no charge for cancellations greater than 14 calendar days prior to the activity, event, or service departure date (\$100 processing fee for private tours).
- You will be charged 50% of the total fee if you cancel between 8 - 13 calendar days prior to the activity, event, or service departure date.
- You will be charged 100% of the total fee for any reservation cancelled within 7 days of the activity, event, or service departure date and for all no-shows.

Minimum Number of People:

Wave Limo & Tours will operate with a minimum of 4 guests per tour or activity.



For speciality services like hourly/personal chauffeur, airport shuttles and others as listed above, Wave Limo & Tours will operate with a minimum of 1-2 people.

If Wave needs to cancel your tour/event, activity, or service, we will give you 24-hours notice and either fully refund or gladly re-schedule for a different day. We promise to do our best to avoid a cancellation at all costs.

For review purposes ONLY. Wave will provide you with an electronic version of this document asking you to verify the following statements by clicking "I AGREE" at the end of each of the sections below.

1. I understand that I am voluntarily participating in a libations tour, event, activity or other service at my own risk and believe that I am in appropriate health and physical condition to participate in all activities.
2. I acknowledge that I am of legal drinking age (19 years or older) as this is required for most inclusions with Wave Limo & Tours.
3. I am also aware that consumption of alcoholic beverages can be a hazardous activity. I am voluntarily participating in Wave Limo & Tours activities, events, and services with knowledge of the potential danger involved, and hereby agree to accept all risks of injury and death, disclaiming any liability of related to the consumption of alcohol.
4. As consideration for being permitted by Wave Limo & Tours to participate in these activities, events or services, I, my assignees, heirs, distributees, guardians and legal representatives hereby waive any and all claims, including those arising out of negligence, against Wave Limo & Tours, it's Directors, Officers, Employees, Independent Contractors, Volunteers, and/or Agents for any injuries or property damage that may arise while participating in Wave Limo & Tours activities, events or services. This includes transportation provided or procured by Wave Limo & Tours while en route to the various facilities including breweries, wineries, cideries, distilleries and all other stops.
5. At any time that I am participating in activities, events or services sponsored or hosted by Wave Limos & Tours, I hereby consent to any medical and/or other treatment that may be considered necessary by a qualified physician, nurse or designated staff member. In case of emergency, I give permission to Wave Limos & Tours to contact



emergency medical services and/or secure treatment for me.

6. I am aware that vomiting due to excessive drinking is prohibited. I understand that I will be charged a \$250 cleaning fee for the required upholstery and interior cleaning should a member of my charter vomit in a Wave Limo & Tours vehicle.
7. Any time that I am participating in activities, events or services sponsored or hosted by Wave Limo & Tours, I hereby consent Wave Limos & Tours to terminate the trip anytime, at their discretion and for any reason to protect the safety and well being of the other participants on said tour.
8. I, the undersigned, give permission to Wave Limos & Tours and/or parties designated by the Company to photograph, record, interview and/or video me while participating in a sponsored or hosted Wave Limo & Tours activity, event or service. I further consent to the use of my name in connection with the photograph(s), recording(s), interview(s) and/or video(s) for any and all promotional purposes including, but not limited to advertising/marketing, promotional, educational, audiovisual, display, exhibition or editorial use. I further consent to the use of my name in connection with the photograph(s), recording(s), interview(s) and/or video(s) by Wave Limo & Tours or parties designated by the Company. I understand and agree that I will not receive any payment for my time or expenses or any royalty for the publication of the photograph(s), recording(s), interview(s) and/or video(s) or the use of my name and I hereby release Wave Limo & Tours and parties designated by the company from any such claims. Further, I agree that any photograph(s), recording(s), interview(s) and/or video(s) together with all copies and reproductions shall constitute Wave Limo & Tours sole property, and that Wave Limo & Tours has the full right to use or dispose of any or all of them in any manner whatsoever and without accountability or payment to me.
9. In Ontario, it is an offence to have any open alcohol containers at any time in any vehicle whether operating or parked. Wave Limo & Tours does not condone drinking in any of its vehicles at any time. If stopped by the Police, the Ontario Justice System can write tickets for the offence as per Schedule 61 of the Ontario Court of Justice amounting to \$100 for each rider and \$175 if the driver is informed that open alcohol is in the vehicle. There are no demerit points lost for the driver. If the driver is fined due to a passenger having open liquor in the vehicle, the group will be penalized equal to the driver's cost of the fine.



10. The Police Officer has the right to remove all open and sealed alcohol if the Officer deems necessary and Wave Limo & Tours is not liable for the loss of any alcohol that is confiscated.
11. Charges, if drinking outside of the vehicle (on the street or any non-licensed property), are the responsibility of the charter guests.

RENTAL AGREEMENT

1. Smoking/Vaping of any substance is not permitted in any vehicle or on any vendors property unless otherwise specified.
2. The client assumes full financial liability for any damages to the Wave Limo & Tours vehicle caused during the duration of the rental by any passenger in the vehicle.
3. The client assumes full financial liability for any damages to any facility visited during a Wave Limo & Tours sponsored or hosted activity, event or service.
4. The client agrees to be respectful and follow the protocols of all the vendors we visit during the charter. Please always abide by their rules and be respectful of their staff.
5. Wave Limo & Tours is not liable in the event of a mechanical breakdown while on charter and has the right to change the vehicle of equal or greater value, or, will be responsible to make up any lost time upon a mutually agreed date.
6. Wave Limo & Tours is not responsible for any lost or stolen property that is left in the vehicle.
7. Alcohol consumption use is prohibited by law; any fines will be covered by the client. This includes fines to the driver.
8. The driver has the right to terminate the charter without refund if there is a blatant indiscretion on the part of any passenger.
9. Wave Limo & Tours will take any action necessary to remove an aggressive passenger from the vehicle during the tour including calling the Police if necessary.
10. Wave Limo & Tours' vehicles cannot be loaded beyond the seating capacity.
11. Overtime will be applied after the first 15 minutes of the pre-arranged end time of the rental as described on the contract.
12. Any outstanding balance and/or gratuities are to be paid to the driver before the charter begins.
13. Wave Limo & Tours is not responsible for delays or termination of the charter due to any U.S. and/or Canadian customs or immigration issues, inclement road or weather conditions, accidents, or any other circumstances out of the Company's control.
